Due to the Michigan Department of Education's transition to the Michigan Student Test of Educational Progress (M-STEP), Accountability data for the 2014-2015 school year does not include school/district-level proficiency targets or final accountability outcomes. This information will resume being a part of the Annual Education Report starting with 2015-2016 data. Graduation, Attendance and Participation Rates are included as a part of the Annual Education Report for the 2014-2015 school year.

Crockett Career & Technical Center does not receive a Michigan Scorecard Status. Crockett Career and Technical Center will continue to support high schools in maintaining/improving their Accountability Status by integrating reading and mathematics skills in the students' technical programs. More specifically, with the assistance of academic integration teachers Career and Technical Education staff will develop lesson plans that include mathematics and reading strategies for the attainment of academic skills. Additionally, Career and Technical Education teachers will provide opportunities for students to engage in lessons in test taking and to provide ACT preparation materials and support sessions.

## **Parent Involvement**

Parents may become involved as follows:

## **Process for Assigning Pupils to the School**

### **Open Enrollment Initiative**

Detroit Public Schools has an "Open Enrollment Initiative." This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The "Open Enrollment Initiative" does not apply to the Examination High Schools or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. It should also be noted that transportation will not be provided for students who select a school outside of the boundary of their home

### **Application Schools**

Detroit Public Schools has twenty-two (22) schools that require an application for enrollment. Families can apply during the application process window. Applications are open to families of current Detroit Public Schools students as well as those newly enrolling or attending school elsewhere. The District uses one application for its Application Schools. Please note requirements on the application for submission of report cards, test data, transcripts, essay and Grade Point Average information. Schools also may have other individual entry requirements. Be prepared to provide behavior reports.

### **Examination High Schools**

During the Examination High Schools application window, all 8th grade students attending public and non-public schools are eligible to apply for admission to the 9th grade at Cass Technical High School, Renaissance High School and Martin Luther King, Jr. Senior High School's Mathematics, Science and Applied Technology (MSAT) and Center for International Studies and Commerce programs. Residency is not required. During the beginning of the school year, students must complete and submit an application to take the placement examination.

Students must submit an application to be eligible to take the examination. Completed applications and all required documents must be submitted to the student's current school or the Detroit Public Schools' Office of Research and Assessment. Detroit Public Schools' students who submit an application will test at their middle school. Non-Detroit Public Schools' students who submit an application will be notified of their testing date and location by mail. Applications may be mailed.

We will continue to work towards meeting our School Improvement Plan goals in reading, writing, mathematics, science and social studies. Research-based strategies, comprehensive data analyses and data driven decision-making drives our school improvement efforts.

## School Description

Crockett provides students the opportunity to become a certified nursing assistant. Students attend the center for a half day, upon graduation, they are prepared for entry-level positions at most healthcare facilities. Some Offerings: CPR and First Patient Care Assisting/Pre-Nursing provides multi-skilled training that is responsive to current changes in the health care industry. Preparation focuses on health care foundation skills and other proficiencies such as body mechanics, patient comfort, surgical patient, phlebotomy, nutrition and elimination, rehabilitation and restorative care, and specimen collection and testing. Upon successful completion of the program, students qualify to earn a Patient Care Assisting (PCA) Certification from the State of Michigan.

The Phlebotomy Technician Program, in partnership with Wayne County Community College, introduces students to medical terminology, the drawing of blood and conducting other specimen collections. Students also learn about healthcare concepts and applications, and gain employability and problem-solving skills. Upon successful completion of the course, students qualify to receive a Certificate as a Phlebotomy Technician.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar. Parents/Guardians are offered classes through Parent University to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Parent Resource Centers are a valuable resource that allow parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. The Detroit Public Schools Hub, Web up-dates and semi-annual progress reports are a means to disseminate achievement information to educators.

The Detroit Public Schools' Office of Research and Assessment has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences (PTC).

- 1.0 Data from the PTC Forms represent "parent interactions" with teachers, per school, per card marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature-a parent may not sign for a student if they did not talk about that student.
- 3.0 Some Detroit Public Schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least two (2) instances, the calculated percentages are in excess of 100%. In each instance, each of these

two (2) schools may have experienced a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
